The Daniel Morcombe Foundation was established in 2005 as a lasting legacy to Daniel. The Foundation was established by parents Bruce and Denise after their son Daniel was abducted and murdered in 2003 on the Sunshine Coast in Queensland. Since then, Bruce and Denise have campaigned to make Australia a safer place for all children.

The Daniel Morcombe Foundation is committed to providing child safety education to children and young people to prevent abuse. We support parents, carers and educators through the provision of resources and education and also directly support young victims of crime.

celebrated one year as our CEO and has progressed many exciting new projects and initiatives. Most notable was Australia's Biggest Child Safety Lesson. Over 100,000 students watched the live stream on Day for Daniel.

Day for Daniel 2017 increased in school registrations and continues to play a part in shaping a child safe community, reinforcing that it is the responsibility of all adults to keep children safe. Our relationships with other charities and agencies have continued throughout the year and we have aligned with Protect all Children Today, (PACT) as well as the Australian Federal Police. Together, we supported Missing Persons Week in August and in Child Protection Week last September with "Tour De Tassie" presenting to schools on the Apple Isle.

I was privileged to be part of a fundraising Trek for women in the Flinders Rangers with nine others organised by Act for Kids. Together, we raised important funds to assist our continued commitment to support children who are victims of crime via counselling and educational, sporting and medical needs with our Walk Tall Programme. Bruce and I were also appointed as National Ambassadors for ACT for Kids. Other fundraising activities included Dance for Daniel in Townsville and Brisbane and Drive for Daniel golf day in Carbrook (organised by the Queensland Travel Industry), all fun events. The Ultra Marathon for Daniel by Billy Tindall and his team was another highlight. Billy completed 1800kms finishing on the Sunshine Coast at Walk for Daniel.

Bruce and my diminished responsibilities at the office, as joint CEO'S, has been challenging and also a time to reflect and to work on our role as Founders. Our exciting new home and counselling facility will be built in the second half of 2018 and is due to open in February 2019. We celebrated the turning of the first sod in May with Kay McGrath, our Patron, and the Hon. Di Farmer, MP, Qld Minister for Child Safety, Youth and Women and Minister for the Prevention of Domestic and Family Violence. Our links and partnerships with government leaders, business people, industry professionals, educators, police and media continue to be strong and vibrant.

Thank you to our committee members, staff and volunteers who are committed to continuing Daniel's legacy and Keeping Kids Safe. In particular, I wish to acknowledge Holly for stepping up to the challenge of continuing to shape and grow the Daniel Morcombe Foundation providing a path forward that excites us all.

1 To educate children regarding their personal safety (including from abduction)

As part of Day for Daniel, we entered the brave new world of online broadcasting. We hosted Australia's Biggest Child Safety Lesson. Our vision was to have the largest simultaneous lesson possible. Bruce and Denise shared the messages of Recognise, React, Report with Sergeant Marty Hunt from Police and Citizen's Youth Club (PCYC). We estimate that over 100 000 students watched the lesson on the day.




As we continue to provide education resources at no cost for children and young people, we are proud to announce that our Keeping Kids Safe resources had an update. Written for a diverse range of students from prep to senior years, the suite contains over 20 videos and activities. They are best used as part of a comprehensive whole school approach to child safety education and are aligned with the following:

- Australian Curriculum, Assessment and Reporting Authority (ACARA)
- · Daniel Morcombe Child Safety Curriculum
- ·Health Promoting Schools Framework
- · Respectful Relationships Education

Bruce and Denise personally visited nearly 50 schools and spoke with over 12 000 students across Tasmania and Queensland. Our focus is on schools providing a comprehensive child safety program that the Foundation can supplement as external visitors. Feedback to Bruce and Denise on their child safety lesson demonstrates strong support for them to continue on their tours.

The Daniel Morcombe Foundation also spoke at several conferences and tertiary institutions about #KeepingKidsSafe in Western Australia, Victoria, New South Wales and Queensland. We love building the capacity of professionals to have those empowering conversations with children and young people.

2 To assist victims of crime, particularly children

The Daniel Morcombe Foundation is proud to announce that this year we have hit our target: Fundraising and spend 1 million dollars in support of young victims of crime.

We assist young survivors of crime by providing everyday items that contribute to the rebuilding of people's lives after they have experienced abuse.

The Foundation has provided support in various ways including tutoring, stationery, laptops and tablets, bikes, helmets and locks, shoes and clothing, counselling, sports equipment and fees, travel fares and zoo visits.

Stacey's story

Stacey is a survivor of abuse. Stacey was able to tell someone and get support. Stacey moved into a foster home and her and her step mother Toni, still support each other today.

The Daniel Morcombe Foundation helped Stacey in many ways through her healing journey. She joined us at the Dance for Daniel March 2018 to tell us a little about her experience with the Foundation including how she became an author and illustrator of a book to help other young people.

Walk Tall Counselling Service

As part of our commitment to ensuring healthy outcomes for children and young people, the Foundation fundraises to support the Walk Tall counselling service run by ACT for Kids.

Located on the Sunshine Coast, Caboolture and Ipswich in regional Queensland, the service provides counselling and support for children and young people who have either experienced or are at risk of physical, emotional and/or sexual harm.

Daniel House



Bruce and Denise, along with the Hon. Di Farmer, Minister for Child Safety, Youth and Women, turned the first sod at a Ground Breaking Ceremony in Palmwoods on May 9 2018, with over 50 invited guests. The building, when complete, will be named Daniel House. It will be the Foundation's administrative hub and will include the Walk Tall program which provides free counselling and support for young survivors of crime.

The Queensland State Government provided \$900,000 in capital works funding to help complete the build. Murphy's Builders have been engaged as the contractor to oversee the project.

Local businesses from the Sunshine Coast have also been very generous in contributing, making this very much a community project. Daniel House has been a decade long dream and this facility will ensure Daniel's legacy lives on.

Dance for Daniel



Emotions ran high several times during the evening at Brisbane City Hall in March as speakers remembered Daniel and thanked Bruce and Denise for their ongoing efforts helping communities across Australia.

The 13th Dance for Daniel raised over \$70 000 towards supporting children and young people to be safe.

Thank you to Kim Skubris our MC Extraordinaire, Swagamama the dance troupe with a difference, Big T and his vocal power, Dave Hughes and his laconic wit, Justin Vievers our wonderful auctioneer and the Kimberley Alexis Band who filled the dance floor.

In Townsville, Dance for Daniel was held in October. More than 350 people honoured Daniel and made Bruce and Denise Morcombe feel like royalty for the work they do keeping kids safe.

Walk for Daniel



Walk for Daniel takes place annually on the Sunshine Coast to launch Day for Daniel. It's the walk that Daniel never finished and is a way that we can remember Daniel and continue to promote the importance of education about personal safety for children and young people. This year's walk was attended by 1200 people, including representatives from all levels of government across a variety of parties as well as local celebrities including members of the Sunshine Coast Lightning team.

Ultra Marathon for Daniel



Billy Tindall's efforts left us in awe, running 1800km from Melbourne to the Sunshine Coast. His dedication and commitment to supporting the Foundation has been inspiring to us and we are grateful. Billy arrived back on the Sunshine Coast in time to join us for Walk for Daniel where he pounded the pavement for another 4kms. A simply amazing effort and thanks again Billy and your fantastic support crew.

• To support the families of Missing Persons particularly children

A national child abduction system known as an Amber Alert was launched this year in Australia. The alert system, which flashes urgent information about missing children via Facebook, is the culmination of a campaign to which the Daniel Morcombe Foundation is proud to have contributed.

The alert via Facebook has strict criteria which means only urgent cases where a child is at risk of death or serious injury and there is information, such as a registration number plate, that can help locate a child, will be used. The Amber Alert is shared within an approximate 160 km radius of where the child has gone missing.

The Daniel Morcombe Foundation is proud to be part of this initiative. It is great to think about social media in a helpful light. There are over 15 million Facebook users across Australia and it could act as a vital resource to reunite children with their families.
